PREP VISION SCREENING



NEW PROCESS FOR SHARING INFORMATION WITH EXTERNAL SPECIALISTS

At Maryvale we understand the value external providers can bring in supporting student learning and wellbeing. To ensure a consistent and secure process when sharing school information with specialists, we have introduced a new External Specialist Request Form. If you would like the school to provide information to your child's therapist, medical professional, or other external specialist, please complete the attached form and return it to the office or email it to the Principal at admin@maryvale.eq.edu.au. This form helps us ensure that all requests are managed respectfully, in line with departmental privacy requirements. Once submitted, you will be contacted to complete a third-party consent form before any information is shared. We appreciate your support in allowing us to work in partnership to support your child.





Supporting your child's wellbeing and learning

Requests for Information and Assessments from External Providers

External providers can offer a valuable service in supporting individual students. At Maryvale State School, we recognise that effective collaboration with these providers can enhance the support a student receives. As part of the external provider's process of assessing need and supporting students, schools may be requested to provide information regarding a student's current presentation, progress, functioning and support needs.

To ensure this information is handled appropriately, Maryvale State School follows best practice procedures, sharing information professionally and in accordance with departmental guidelines and privacy requirements when responding to requests from external providers.

	Requests for student information for external providers are to be made in writing through the Principal. Complete the below form and return to the administration office or alternatively, email: principal@maryvaless.eq.edu.au	
0	Parent/caregiver consent must be documented prior to the school responding to the request. Following your request for information a third-party consent form will be provided to you. The Department of Education needs consent in writing before it uses, records or discloses personal information, or materials, with third party individuals and organisations. You can withdraw your consent at any time in writing by emailing the principal. Further information is included in the explanatory letter.	
	A three-week timeframe commencing on the receipt of requests is required, out of respect for our teacher's valuable time.	
	Any tests or questionnaires must be provided in paper form or emailed PDF. Online assessments cannot be completed as they breach Department of Education policy around storing information offshore.	
	Information requested will be emailed and posted directly to the external provider. A summary of results or a copy of any ensuing reports should be provided to the school.

Primary School Nurse Health Readiness Program

Vision screening

Information for parents and carers

The Primary School Nurse Health Readiness Program (PSNHRP) is a free Queensland Government initiative offering vision screening for children in prep.

The PSNHRP has a team of highly trained registered nurses based across Queensland who will attend your child's school during their prep year to conduct vision screening.

The vision screening checks for common eye conditions that may impact your child's ability to see and have an impact on their learning and development.

What do we do?

- This program screens your child's vision using two noninvasive screening tools.
- Screening takes less than five minutes on date/s agreed by your school, with minimal disruption to your child's learning.
- Before screening, the registered nurse will talk to your child's class about the vision screening process and will ask your child their full name, date of birth and their parent or legal guardian's name to identify them.
- Parents do not need to be present for screening but if you
 would like to be, please contact the school to arrange this.
- If your child's vision is screened, you will be sent the results in writing. If a vision concern is found you will receive a phone call from the nurse to discuss referral to an eye health professional for further assessment.



What do you need to know?

- Your child's school will distribute a vision screening consent pack during their prepyear. Please complete it and return it to the school as soon as possible.
- The program does not screen for colour blindness and is not funded to screen your child's hearing.
- If a vision concern is identified and your child requires glasses, eligible health care card holders may be assisted with free basic glasses through the Spectacle Supply Scheme (SSS) www.health.gld.gov.au/mass/prescribe/spectacles
- If you have concerns about your child's eyes at any time, please take your child to see an eye health professional (optometrist/ophthalmologist).
- This program utilises free interpreters/translators to assist you, if required.
